**How:** Fill out a registration form


We have confirmed a spot on the distribution of the vaccine and have contracted the Visiting Nurse Association (VNA) to administer it. However, due to the Health Department's distribution protocol, they currently do not know when the exact date will be. We are looking at the end of February and perhaps into March.

In the meantime, we are starting registration so that we can quickly confirm and administer the shots when the supply arrives. A registration form is included in this flyer and also available at the Front Desk.

Note: An email address is required. Your confirmation will be sent by email, please check your inbox and spam on a regular basis.

- The Health Department is providing a supply of vaccines to the VNA for Del Mesa residents aged 75+, and any home healthcare providers to Del Mesa residents.
- Residents between the ages of 65 and 74 may choose to register on our waitlist in case the Health Department opens up the vaccine to the 65+ age group before our vaccination date arrives.
- Vaccine allotment prioritizes areas that are hardest hit before they move on to the Carmel area. We are waiting for the Health Department to notify VNA of their supply date and only then can a vaccination date be set.
- VNA will not know the brand of the vaccine in advance.
- The vaccination will be administered in 2 doses that are 28 days apart. You
  must be available for both appointments.
- Everyone must be pre-registered. Walk-ins will NOT be accepted.
- An email address is required to sign up. You will receive an email confirmation with a date and time once a clinic date is confirmed. Please check your emails.
- At the time of your appointment, bring:
  - Government ID such as Drivers License, State or military ID
  - Health insurance card
- **Sign-up requirements are:** be a Del Mesa resident (or caregiver to a resident), must pre-register, must be at least 75-years old.
